



Memorandum of Understanding between

Chiang Mai University and Kobe Gakuin University

Chiang Mai University and Kobe Gakuin University, wishing to establish relations between the two universities, agree to cooperate with each other as follows:

Article 1. Chiang Mai University and Kobe Gakuin University will cooperate to facilitate mutual friendship, academic research and educational cooperation.

Article 2. In order to promote the cooperation described in Article 1, the two universities may undertake various activities such as those listed below:

- (1) Exchange of students and/or interns
- (2) Exchange of faculty and/or staff
- (3) Joint research activities
- (4) Other activities mutually agreed upon by the two universities.

Article 3. The details of other activities will be determined on a case by case basis and be specified through separate negotiations. Both universities assure to make resources available to facilitate mutual exchange and general cooperation.

Article 4. This Memorandum of Understanding shall become effective after the date of signing by the official representatives of the both universities and shall remain in effect for an initial period of five years, with understanding that it shall be automatically renewed from year to year; however, either university may terminate the Memorandum of Understanding by giving six months advance notice in writing of such intent. Such termination shall not affect the validity and continuity of any incompletely discharged obligation agreed upon by the two universities before termination.

Article 5. This Memorandum of Understanding and specific collaboration resulting from it may be modified or amended at any time by mutual consent of the two universities.

Article 6. This Memorandum of Understanding shall not bind either university to any financial commitment.

Agreement for Student Exchange Program between Chiang Mai University and Kobe Gakuin University

1. Purpose of programs

The general purpose of this agreement is to summarize the criteria for participation in student exchange programs for students between Chiang Mai University (hereinafter referred to as CMU) and Kobe Gakuin University (hereinafter referred to as KGU).

2. Details of exchange programs

The number of exchange students, and period of exchange of study and status per year:

- a) CMU and KGU agree to take two students from any of the program from their respective faculties for a year, respectively.
- b) Should there be any case of an imbalance, the overall total of exchange students and/or the time period of the student exchange program will be reconsidered and be adjusted.

3. Selection of students

Each home university will determine the selection of students for the exchange programs by its own method and ascertain that each of its students is likely to benefit from a particular course of study at the host university. Equivalency between courses and programs will be agreed in accordance with the purpose of awarding academic credit.

4. Recognition of credits

Within the scope of its own regulations, each home university will admit the credits that its students gained at the host university.

5. Expenses relating to exchange programs

Each student will pay tuition fees to the home university and will be exempt from fees at the host university.

6. Accommodation

Both universities will offer secure and appropriate information for accommodation to exchange students.

7. Rules and Regulations

Exchange students shall be accorded the same rights of regular students at the host university and subject to the rules and regulations of the host university.

8. Period of arrangement

8.1 This agreement is effective for 5 years after the date of signing, and is renewed automatically as long as neither party gives notice of termination to the other.

- 8.2 Either University may, by written notice of six(6) months, give notice to the other of its intention to terminate this arrangement.
- 8.3 If the agreement is terminated as set out in Clause '8.2', it is agreed that both parties will work together to ensure that cooperative activities that have already commenced are, wherever possible, completed under the terms of the agreement.

9. Other terms and conditions

Other terms and conditions which are not specified in this agreement will be negotiated further between the administrative staff members.

This agreement was negotiated between CMU and KGU. No amendments, consent of waiver of terms in this arrangement shall bind either party unless it's written and signed by both parties.
