



**GENERAL AGREEMENT OF COOPERATION**  
**between**  
**UNIVERSITY OF HEALTH SCIENCES, LAO P.D.R.**  
**and**  
**CHIANG MAI UNIVERSITY, THAILAND**



University of Health Sciences located at Samsenthai Road, Phiawath, Sisattanak District, Vientiane Capital, The Lao People's Democratic Republic, represented here by its President and Chiang Mai University located at 239 Huai Kaeo Road, Suthep, Mueang, Chiang Mai 50200, Thailand represented here by its President, sign the present agreement according to the following clauses:

FIRST: The agreement is based on reciprocal aims of both parties to cooperate in the exchange of scientific and academic activities as well as an exchange program of faculty members and undergraduate and graduate students.

SECOND: University of Health Sciences and Chiang Mai University agree to exchange of information, publications, materials and experiences related to the different scientific fields each institution offers.

THIRD: Both parties agree to establish exchange programs for researchers, faculty members and students of all levels.

FOURTH: Both parties agree to develop joint projects in teaching, research and publications in order to contribute to the scientific and technological enrichment of both institutions.

FIFTH: The specific activities developed in order to achieve the proposed aims will be determined for each occasion by means of specific agreements, according to the availability of resources.

This agreement will be in force for five (5) years since its signature and will be automatically extended if any of the parties does not manifest the contrary two months before it is due to expire. Either party may terminate this agreement at any time by giving six months' notice in writing to the other party. Any modifications concerning the present agreement may be made only by mutual consent in writing between authorized representatives of the parties.
