Whereas, both Chiang Mai University and California State University, Fullerton (hereinafter referred to as "the Parties") recognize the importance of exchange in Thailand-U.S. economic and social development; and

Whereas, the parties recognize the active role that exchange plays in enhancing mutual understanding, friendship and good relationships between the American and Thai peoples;

Now therefore, after friendly discussion, both parties agree as follows:

1. To actively promote academic exchange and cooperation between the two parties, which will lay a sound foundation for more extensive exchange and cooperation in area such as but not limited to; exchange of faculty members and researchers, exchange of students, joint research, lectures, talk and symposiums.
2. To seek close contacts and collaborate on using the abundant resources of the two parties to pursue education and training opportunities of mutual interest;
3. To collaboratively develop the details of program content and financial arrangements, and specify them in a supplemental agreement that will be signed by President Niwes Nantachit of Chiang Mai University and President Framroze Virjee of California State University, Fullerton.

This letter of intent will be effective for five years, starting from the date on which it is fully signed by the presidents of both institutions.


